As the Company was incorporated in the PRC, the concept of “authorised share capital” is not applicable. The information contained in section I refers to the “issued share capital” of the Company.

Remark 1 :On 9 January 2017, 49,730,000 H shares were issued by the Company pursuant to the partial exercise of over-allotment option and 4,973,000 H shares were converted from the Company’s A shares transferred to NSSF in accordance with the relevant PRC regulations regarding reduction of state-owned shares upon the exercise of the partial over-allotment option. As a result, the total number of H shares was 533,643,000 as at 9 January 2017.

Remark 2: On 9 January 2017, 4,973,000 A shares were cancelled in the register of members of A shares. On 9 January 2017, such 4,973,000 A shares were transferred to NSSF and converted to the Company’s H shares in accordance with the relevant PRC regulations regarding reduction of state-owned shares. As a result, the total number of A shares was 2,418,791,675 as at 9 January 2017.
